

ACS COUNCIL MEETING MINUTES ATLANTA, GEORGIA - APRIL 17, 1991

The Council meeting convened at 8:00 a.m., April 17, 1991 in the Atlanta Hilton Hotel, Atlanta, Georgia. All Maryland Section councilors were present.

The first action of Council was to select two nominees for president-elect of the Society for 1992. Nominees proposed by the Committee on Nominations and Elections were Frederick E. Bailey, Helen M. Free, George E. Heinze and Henry F. Whalen, Jr. After brief talks by the proposed nominees, the Council chose Helen M. Free and Henry F. Whalen, Jr., to run for ACS president-elect.

Any ACS member is eligible to nominate a member for consideration for ACS national offices. Recommendations can be made to Dr. Robert L. Soulen, Chair, Committee on Nominations and Elections, Chemistry Department, Southwestern University, Georgetown, Texas 78626.

ACS President S. Allen Heininger reported that there were four key areas on which he will focus attention during his term as president: public appreciation of chemistry, National Chemistry Week, service to industrial members and Chemical Abstracts Service governance streamlining.

Joseph A. Dixon, Chair of the Board of Directors, reported on major Board agenda items:

- A CAS study group, composed of five senior chemical and information industry members, concluded that the "present ACS governance of CAS is inadequate to provide the degree of control and accountability necessary...in the highly competitive nature of the chemical information marketplace". Numerous recommendations were presented by the group and will be studied by the Board.
- Because of the size and complexity of the Dialog suit, events are moving slowly. The suit is unlikely to go to trial before 1992.
- 3. The Society's financial performance in 1990 was approximately \$560,000 below target. This was due to a lower than budget return from Publications.

Executive Director John Crum announced that total ACS membership reached 142,559 in 1990. As of January 25, the Campaign for Chemistry (which will pay for a chemistry exhibit at the Smithsonian) had received over \$25 million in gifts and pledges. There will be a reduction in ACS staff in both Washington and Columbus in order to save money.

The Council voted on a member dues increase of \$5.00. Dues for 1992 will be \$91.00. The increase was needed in order to continue to fund member services.

There is a new ACS insurance policy available to members - emphasizing home and long term care. The policy is available to members under 80 years of age. For information call the ACS insurance office in Washington (1-800-227-6558).

At an earlier meeting, Dr. Charles Rowell, U.S. Naval Academy, was chosen to chair the MARM Councilors Caucus for 1991-1992.

Student Awards: The Student Award meeting at Western Maryland College went well.

W. R. Grace & Company Award: Robert B. Kennedy, President and CEO of Union Carbide, was chosen to receive the Award. The Award will be presented on October 22, 1991 at W. R. Grace Research Labs at the Section's October meeting.

Chemical Education & Safety: No report. A new chairperson is needed for this committee.

PROPOSED IDEAS:


- ESTABLISH A NETWORK OF CURRENT AND POTENTIAL FACULTY ADVISERS. THOSE GATHERED VOLUNTEERED TO CONTACT THE ONES NOT PRESENT.
- CALL A MEETING OF INTERESTED FACULTY ADVISERS IN LATE SUMMER OR EARLY FALL TO STRENGTHEN OUR EFFORTS.
- 3. PROMOTE NATIONAL CHEMISTRY WEEK OF NOV. 3-9, 1991 BY COORDINATING WITH THE MD LOCAL SECTION. THIS EVENT SHOULD BE ORGANIZED TO BRING AS MANY STUDENTS AND FACULTY ADVISERS AS POSSIBLE. THE EVENT WILL BE COORDINATED WITH MR. JOSEPH YELLIN OF HARFORD COMMUNITY COLLEGE.
- 4. ORGANIZE AN AWARDS EVENT FOR THE MOST ACTIVE CHEMISTRY/SCIENCE CLUB IN THE MD LOCAL SECTION EACH YEAR. THIS EVENT WILL BE COORDINATED WITH THE LOCAL SECTION SO THAT IT MAY BECOME A PART OF MONTHLY MEETING IN APRIL.
- 5. ORGANIZE AN ANNUAL PICNIC OR OTHER SOCIAL ACTIVITY.
- SPONSOR A JOBS/CAREER FAIR FOR STUDENTS IN CONSORTIUM. ACS NATIONAL OFFICE WILL SUPPLY USEFUL MATERIALS.

Once contacts are made with the other faculty advisers, future plans of the consortium will be announced.
